



FAST RESCUE CRAFT

This course provides participants with the knowledge and skill to safely operate a Fast Rescue Craft (FRC) and manage its crew during operation.

The course is designed for seafarers who require AMSA endorsement and for personnel who work on floating production storage/offloading units (FPSO) and/or floating storage offloading (FSO) vessels.

Structure and Assessment

This course is delivered through classroom presentations, group discussion and practical elements. Assessment is carried out via written assessment, direct observations & practical exercises including the operation of a Fast Rescue Craft.

Revalidation

It is an AMSA requirement to successfully revalidate Fast Rescue Craft (STCW Reg V1.2) every 5 years.

Authority / Regulator

The Australian Skills Quality Authority (ASQA) is the national regulator for Nationally Recognised Training delivered by Australia's vocational education and training sector.

STCW training delivered in Australia is regulated by AMSA, which is Australia's national agency responsible for maritime safety.

Fast Rescue Craft - Nationally Recognised Training Course

Designed for personnel working on a floating production storage and offloading Unit (FPSO) or floating storage offloading (FSO) vessels.

Fast Rescue Craft – Standards of Training and Certification for Watchkeepers (STCW) Course

Designed for seafarers who need AMSA endorsement after completing the course.
